It is with great pleasure that Anacapa Working Dog Association (AWDA) submits our bid to proudly host the 2010 USA SW Regional Schutzhund Championship.

AWDA is a Full Member club in good standing. We have an excellent venue selected to host this event in Ventura, California. We have many excited, dedicated club members who have pledged their help and support to host a successful event.

AWDA understands the importance of such a significant event. We fully appreciate the amount of effort and hard work it will take to host the SW Regional Schutzhund Championship.

AWDA respectfully submits our proposal as follows:

*Requirements to Host the SW Regional Schutzhund Championships*

- #1: Club Name: Anacapa Working Dog Association (AWDA)
- #2: No conflicting dates are on the current calendar as of the date of submitting this bid proposal.
- #3: Dates Proposed for the 2010 USA SW Regional Schutzhund Championship are:  
March 26<sup>th</sup> through March 28<sup>th</sup>, 2010

The weather for the Ventura/Oxnard area for the proposed dates is traditionally very comfortable and mild for hosting this type of event. The days are comfortable in the mid 70's with calm nights in the low 60's. With 354 days of sunshine per year, rain is not typical.

#4: Stadium: High School Football Stadium

This is an exceptional venue with plenty of parking, vendor area, seating and concession ability. The field is well maintained, fenced and secure. The venue will contribute to a memorable event for spectators, competitors, judges and helpers.

#5: Tracking will be on the natural terrain of Plowed Dirt and will be within a short drive of the Stadium.

The Ventura area has large open flat parcels of land that offer some of the best tracking fields in this part of the country.

#6: Judges at this time are still to be determined. Since this event is still a year out, securing a judge at this time may not be practical. Once the bid process has been completed and a club awarded the privilege of hosting the event, securing a Judge(s) will not be an issue.

#7: Additional Judges will be selected in advance and added when required, depending on the number of entries.

#8: Helper selection and determination is a similar process to selecting a judge. Again, once the bid process has completed, and a club awarded the privilege of hosting the event, securing Helpers will not be an issue.

Anacapa Working Dog Association is committed to organizing the best venue, judges, helpers, and all other necessary items for an event of this magnitude. All the efforts necessary to secure a successful 2010 USA SW Regional Schutzhund Championship have been addressed by AWDA.

Hotels are abundant and many are within less than 10 minute drive from the venue. There are many affordable RV and camping locations in the area. Many of the camping locals are right along the Pacific Ocean and are just a short drive to the Stadium.
